Letter from the Board Chair



The Early Learning Coalition of Pasco and Hernando Counties is proud of a remarkable year that began in search of a new executive, and closed with a strong leader and unified board. With clear and definitive focus on children, we recruited a leader with a wealth of education experience, a voice for children, and consummate consensus building skills.

Our Board of Directors has rallied around our staff, developed a long term strategic plan, and proudly speaks with one voice. Through the skills of our Executive Director we have a lean and purpose driven organization that is highly responsive to the needs of children.

Our 4,401 children served in School Readiness was accomplished through tight fiscal management and adhering to the core of our mission "Children First." Voluntary Pre-Kindergarten achieved higher attendance than preceding years with 4,550 children enrolled. Furthermore, we increased our average readiness rate, and again exceeded the State average.

One of our signature programs, PEEP (Pre-school Early Education Program), which meets the needs of children birth through five years old through Inclusion Services, is now in its fifth year. This is a hallmark quality initiative that provides mental health and behavior management services to children in need. By expanding the program throughout our communities, we more than tripled the number of children served to 174. Healthy children, in mind, spirit, and body, are essential to successful learning.

A new endeavor for the Coalition this year is our Jump Into Early Learning series. Modeled after Operation Backpack, we distributed 780 pre-school backpacks with assorted school supplies. At each of the four events, we were knee deep in children and shoulder to shoulder with dozens of parents, providers, and community members. The rooms were packed with people, and the atmospheres electric with enthusiasm. The giveaway's, announced in both English and Spanish, were eagerly accepted with gratitude. We were also fortunate to have various dignitaries attend these events, from AWI Director Monesia T. Brown, to State Representative Wil Weatherford, and both Pasco and Hernando County Commissioners.

Our Resource Van clocked thousands of miles attending 18 community events, and making more than 600 provider visits. The van also gave away more than 2,500 books to our littlest children.

Preschools are the incubators from which emerge our current and future students, employees, parents and citizens. The quality of experience they receive in these early, formative years will set the stage for their future successes. It is our job to ensure that each child within our collective communities receives services of the highest quality from trained, compassionate and loving professionals.

The Early Learning Coalition of Pasco and Hernando Counties embraces the stewardship bestowed upon us to ensure that all of our small children are elevated to a successful level and grow to carry the torch for those yet to be born.

Courses, scholarships and provider improvement incentives are but some of the many opportunities offered to our childcare providers during the past year. Outcomes and Success

- VPK programs continued to be successful in their second year of operation. Figures for the 2006-2007 year indicated that Volunteer Pre-kindergarten providers in Pasco and Hernando Counties received an average readiness rate in excess of the state average.
- Provider meetings were organized and presented by the Coalition with a primary focus on professional and business development.
- The Coalition made significant staff changes and additions, resulting in a more effective means to provide early childhood services within our communities.
- INCLUSION of all eligible and registered children, regardless of special need, has become a
 major focus of Coalition efforts with Providers, through the professional services of trained and
 experienced Coalition Inclusion Specialists.
- Dramatic increase in Provider reliance on the Coalition's Mobile Outreach Resource Van. The Outreach van visits Providers daily, attends provider meetings, community events, and acts as a mobile resource library for providers.

Programs

Achievements and Outcomes

Pasco

A total of 3,230 unduplicated School Readiness children in Pasco County were in care during the 2007-2008 year, representing an increase of 71 children over 2006-2007 unduplicated enrollment. There were 324 children on the School Readiness waiting list as of June 30, 2008. A total of 3,400 Pasco County children were enrolled in 2007-2008 VPK programs (School Year and summer combined), representing an increase of 889 children over 2006-2007 VPK program enrollments.

Hernando

A total of 1,171 unduplicated School Readiness children in Hernando County were in care during the 2007-2008 year, representing a decrease of 126 children from 2006-2007 unduplicated enrollment. There were 356 children on the School Readiness waiting list as of June 30, 2008. A total of 1,150 Hernando County children were enrolled in 2007-2008 VPK programs (School Year and summer combined), representing an increase of 135 children over 2006-2007 VPK program enrollments.

School Readiness

The School Readiness program provides subsidized child care for working poor families. This program fuels the economy of our community by allowing parents to afford safe and reliable child care. Eligible families are assessed a fee on a sliding fee scale according to income. Without help in paying for child care costs, parents often have no choice but to quit their jobs, as the full costs of child care can consume as much as 60% of salaries and wages.

The children in school readiness programs are assisted through screenings, assessment and developmentally appropriate early learning programs to ensure they are prepared for school. Our focus is serving children from birth to age five and school age children with younger siblings.

Hernando

Voluntary Pre-Kindergarten

Voluntary Pre-Kindergarten is a program passed and funded by the Florida Legislature providing 540 hours of free, school-year pre-kindergarten services for children who are four years old on or before September 1 of the current school year. As an alternative, there is a shorter (300 hours), but more intense program offered during the summer. This program, free to parents regardless of income, is offered at participating licensed private child care centers, accredited faith based centers, many public school and Head Start sites, as well as licensed family child care homes. The goal of the program is to provide quality pre-kindergarten experiences for young children such as self-management and emergent literacy skills, to assist them in becoming ready for kindergarten. Providers are the key to the success of the VPK program and we consistently offer trainings and technical assistance to our early learning educators to ensure our children receive the best possible start on their future.

Quality Initiatives

Efforts to improve the quality of services available to young children and their families are a primary concern. The Coalition sets aside a portion of the funding received to target these issues. The Coalition employs two full time Inclusion Specialists.

Single Point of Entry/ Resource and Referral

Families are able to apply for VPK and School readiness services through the single point of entry system online in Pasco and Hernando Counties. After a family is identified as being eligible to receive subsidized child care, they are placed on a Unified Waiting List according to Coalition priority. Families are contacted and offered subsidized child care based on eligibility and availability of funding.

Child Care Resource and Referral is a part of the statewide Child Care Resource and Referral Network funded by the Agency for Workforce Innovation/Office of Early Learning. This is a free service to help parents, regardless of income, in locating quality child care services close to home or work. Resource and Referral also assists potential providers with information they need to become a provider. Through the CCR&R database, families are given the full range of options for their child care selection.



Program Issue and Response

Program Issue

Warm Line calls were noted as describing similar provider challenges, often behavioral in nature, concerning different children.

Coalition Response

Inclusion staff focused intervention efforts on providers and classroom staff, rather than on individual children. Teachers were instructed in effective intervention strategies for the referred child, which could be useful with others as well. Children who were not responsive to such initial strategies were referred for in-depth evaluation and intervention through the Coalition and its contracted consultants.







- Assure availability of subsidized child care services to all qualified families, without waiting list





Grant Allocation




Actual Spending




Voluntary Pre-Kindergarten
